- 3. 'OCEAN WAVES' (3 images) Try taking various shutter speeds to get different effects, even 1/15<sup>th</sup> sec (filters help)
- 4. 'The OLD days vs TODAY Landscape Comparisons' 3 sets of 2 images Before & After
- 5. NEW SUBJECT to SUBMIT for the meeting ... So that we can appreciate how horrific the fires have been, and be humbled by what other Australians have been through, please submit 5 images of fire affected areas

### The OLD Days vs TODAY' Task

Submit old images of locations, together with images showing the same place now, showing the differences in the location (Now & Then) ...

Maybe scanning the old image, or take the old image on your phone, then go to the same location and try to replicate the old with the new





When you submit your images, they will need to be in sets of 2 (Before and After) cropped to the same size if possible (as above).
